THE CONSTITUTION

LUKOMONA CHRIST EXCHANGE PROGRAM (LuCEP) FOUNDATION

Kindly note: This Constitution will be implemented in the future once the LuCEP Germany HQ has assessed and confirmed that the foundation is operating according to plan. We appreciate your patience and support in this process.

PREAMBLE

We, the members of the Lukomona Christ Exchange Program (LuCEP) Foundation, acknowledging the Lordship of Jesus Christ and the Great Commission (Matthew 28:19-20), do hereby establish this constitution to guide our mission, vision, structure, and operations in fulfilling our divine mandate. We are committed to spreading the Word

of God, empowering Christian leaders, and serving communities across Germany, Europe, Africa, and beyond.

ARTICLE 1: NAME

The organization shall be known as **Lukomona Christ Exchange Program (LuCEP) Foundation**, hereinafter referred to as **LuCEP**.

ARTICLE 2: MISSION AND OBJECTIVES

2.1 Mission

To **enhance the Word of God** across Germany, Europe, and the Western world by equipping African Church leaders, Christians, and faith-based organizations with the necessary resources, training, and platforms to spread the Gospel effectively.

2.2 Objectives

- 1. To **facilitate cross-cultural faith exchange** between African and Germany-European churches, and other western countries.
- 2. To promote evangelism and Christian discipleship.
- 3. To **train and empower** African church leaders for effective ministry.
- 4. To **establish Christian support structures** for African immigrants in Germany and Europe.
- 5. To **support Christian social programs** for vulnerable groups, including refugees and the underprivileged.
- 6. To **publish faith-based materials** to guide and strengthen Christian leadership.
- 7. To collaborate with other Christian organizations for joint missionary efforts.

ARTICLE 3: CORE VALUES

- 1. Faithfulness to the Word of God Rooted in Biblical truth.
- 2. Servant Leadership Leading with humility and integrity.
- 3. Unity in Christ Embracing diversity within the body of Christ.
- 4. **Excellence in Ministry** Striving for spiritual and organizational excellence.
- 5. **Compassion and Outreach** Serving the vulnerable and spreading love.
- 6. **Cultural Integration** Bridging the gap between African and European Christian communities.

ARTICLE 4: MEMBERSHIP

4.1 Eligibility

Membership shall be open to individuals and organizations that:

- Confess Jesus Christ as Lord and Savior.
- Support the mission and objectives of LuCEP.
- Are committed to active participation in LuCEP activities.

4.2 Categories of Membership

- 1. **Ordinary Members** Individuals actively engaged in LuCEP activities.
- 2. Associate Members Organizations that collaborate with LuCEP.
- 3. **Honorary Members** Recognized Christian leaders and patrons who support LuCEP's mission.

4.3 Rights and Responsibilities

Members shall have the right to:

- Participate in LuCEP programs.
- Elect and be elected into leadership positions.
- Receive spiritual and ministerial support.

Members shall be responsible for:

- Upholding LuCEP's mission and values.
- Actively engaging in evangelistic and training activities.
- Contributing to the spiritual growth of LuCEP and member churches/organizations.

ARTICLE 5: GOVERNANCE AND LEADERSHIP

5.1 Organizational Structure

LuCEP shall be governed by the following bodies:

- 1. **The Board of Trustees** The highest governing body providing strategic oversight.
- 2. **The Executive Committee** Responsible for daily operations and administration.
- 3. **Regional Coordinators** Supervising activities in different countries.
- 4. Church and Community Leaders Implementing LuCEP programs at the grassroots level.
- 5. And others that may be agreed and voted upon by members.

5.2 Leadership Positions

- 1. **President/Founder** Provides spiritual and strategic leadership.
- 2. Vice President Assists in governance and administration.

- 3. **General Secretary** Oversees documentation and communication.
- 4. Treasurer Manages financial matters.
- 5. **Evangelism and Training Director** Coordinates faith-based programs.
- 6. **Community Outreach Coordinator** Leads social and humanitarian projects.

ARTICLE 6: MEETINGS AND DECISION-MAKING

- 1. **Annual General Meeting (AGM)** To review the organization's progress and elect leaders.
- 2. **Executive Committee Meetings** Held quarterly to discuss operational matters.
- 3. Special Meetings Convened as needed for urgent matters.
- 4. Decisions shall be made through prayer, consultation, and majority voting.

ARTICLE 7: FINANCIAL MANAGEMENT

- 1. LuCEP shall be financed through donations, grants, and fundraising.
- 2. All funds shall be transparently managed in accordance with financial policies.
- 3. Annual financial reports shall be presented at the AGM.

ARTICLE 8: AMENDMENTS TO THE CONSTITUTION

This constitution may be amended by a **two-thirds majority** of members present at an AGM, provided that:

- The proposed amendment is submitted **at least three months** before the meeting.
- The amendment aligns with the vision and mission of LuCEP.

ARTICLE 9: DISSOLUTION

In the event of LuCEP's dissolution:

- 1. All debts and liabilities shall be settled.
- 2. Remaining assets shall be **donated to a like-minded Christian organization**.
- 3. The decision to dissolve must be approved by a **two-thirds majority** of the Board of Trustees.

ARTICLE 10: FINAL PROVISION

This constitution shall take effect upon its **adoption by the LuCEP leadership** and shall serve as the guiding document for all LuCEP activities.
